Terms and Conditions

- 1) The following terms and conditions ("the Conditions") apply to this agreement between Montrose Restaurant ("the Restaurant", "we" or "us" depending on context) and you, the member named above ("you" or "member" depending on context).
- 2) By completing and returning this application form, you confirm your agreement to the Conditions and agree to become a member of the Montrose Dining Club ("the Club").
- 3) You agree to join the Club for an initial term of 12 months and any period after the initial term pending renewal of this agreement ("the Term") subject to your right to cancel pursuant to clauses 12, 13 & 15.
- 4) You agree to pay the membership fee of £197 per calendar month ("the Membership Fee") during the Term, the first such payment shall be made on the date of commencement of your membership and subsequent payments shall be made on the same day of subsequent months.
- 5) In consideration for you paying the Membership Fee, we will provide you during the Term with credits for use in the Restaurant to the value of £300 per month ("the Credits").
- 6) We will also provide you with additional benefits throughout the Term ("the Benefits"). The Benefits will be set by us throughout the term and we reserve the right to change, remove or add to the Benefits as we see fit in our absolute discretion.
- 7) The Credits can be used at all times at the Restaurant but cannot be used in conjunction with other promotions being offered by the Restaurant.
- 8) Any Credits remaining at the end of a month (being a month from and including the date of payment of the Membership Fee for that month) may be rolled over for up to a maximum of six months. Any further allowances in respect of rolling over Credits for more than six months may be granted by the Restaurant in its absolute discretion.
- 9) Your membership is non-transferable. You must notify us as soon as possible if you become aware of any unauthorised use of your membership card or if your membership card is lost or stolen. Replacement membership cards in the event of loss or damage will be issued to the member at a cost of £10, such cost to be borne by the member.
- 10) Your membership card is not a credit, payment or cheque guarantee card.
- 11) Your membership card must be produced at the restaurant at any time after your arrival to take advantage of accrued Credits or Benefits.
- 12) You have the right to cancel your membership within ten days of the date of commencement of your membership. If you wish to do so then you may by giving us notice in writing.
- 13) You have the right to cancel this agreement at any time after the date which is six months from the date of commencement of your membership provided that you give us at least one month's written notice in advance and the Membership Fee is paid up to the date of termination of this agreement. The notice should be delivered to the restaurant.
- 14) Your personal details will be held by the Restaurant and will be used exclusively by the Restaurant (and not passed to any third parties) for membership administration and marketing purposes only.
- 15) We reserve the right to cancel your membership without notice if you breach these Conditions.
- 16) These Conditions may be varied at any time at the absolute discretion of the Restaurant. When such a variation occurs, the restaurant will use its reasonable endeavours to give you notice of the variation. If you wish to cancel your membership following receipt of notice of a variation then, notwithstanding clauses 12 & 13 of these Conditions, you may do so provided that you give us at least one month's written notice in advance within 7 days of the date of the notice and the Membership Fee is paid up to the date of termination of this agreement.
- 17) These Conditions shall be governed by and construed in accordance with UK law.
